Animal Liberation is producing this report to further enhance communication with members, supporters and potential animal advocates.






**ADMINISTRATION:** Administration staff expense, insurance, office rent, web development and hosting, postage, telephone, and electricity.

# CAMPAIGNS

# THE COALITION OF AUSTRALIANS AGAINST 1080 POISON

Since forming the Coalition with other like-minded organisations and individuals, a key campaign has been the ongoing battle to ban 1080 poison throughout the country. As the only group providing expert advice to the families of victims and the broader community alike, the Coalition has experienced a groundswell of popular support. Our social media channels have attracted over 12,000 followers, with several posts reaching over half a million users. One of the primary methods we use to raise awareness is sharing first-hand accounts sourced from supporters who have experienced the trauma of losing a loved one to 1080. In doing so, we have firmly established ourselves as trustworthy and determined advocates who are willing to take reports to authorities to secure justice for grieving families. We have secured these stories in the public consciousness, with the publication of several articles on the front page of nationally syndicated newspapers and prime time television.

#### **SUBMISSIONS**

Over the four decades in which Animal Liberation has worked to permanently improve the lives of all animals, we have submitted countless submissions to such inquiries. To share our accumulated experience and expertise in animal justice issues, we regularly draft templates which supporters use to create their own submissions. In the past year alone, we have researched, written to these Commonwealth, State and local inquiries:

- The Kangaroo Commercial Review: amendments to the National Code of Practice
- The Independent Review of the Environment Protection and Biodiversity Conservation Act
- The Inquiry into the Criminal Code Amendment Bill
- The NSW Animal Welfare Reform
- The Inquiry into Australia's Faunal Extinction Crisis
- Submission to a Development Application (DA) for an intensive piggery in rural NSW (ongoing)
- The Inquiry into the Problem of Feral and Domestic Cats (ongoing)
- The Inquiry into the Long-term Sustainability of the Dairy Industry (ongoing)

#### **SOCIAL MEDIA**

Animal Liberation's socials are used to update our followers on our campaigns, raise awareness about all forms of animal exploitation, and encourage consumers to adopt a vegan diet.

This year we released a 21-Week Guide to Becoming a Conscious Consumer. The guide provides people with an insight into the animals, the industry and standard practices, while also addressing the environmental and health impacts of our desires to eat, wear, and exploit animals.





# STAFF

## **BARRIE TAPP | 1800 CRUELTY HOTLINE AGENT**

Barrie Tapp and the 1800 Hotline completed another busy and productive year that included investigating complaints and rescues, lobbying and reporting matters to authorities. Barrie took over 200 calls around Australia and in turn, made quadruple calls to enlist help for animals. While Covid prevented him from travelling to sale yards and other enquiries he was busy focusing on pony/horse riding facilities and his tenacious work had media running articles for perhaps the first time on the unregistered exploitation of these animals. Barrie also made representation on behalf of systemic cruelty and neglect at a property with former racehorses. Other cases included unprofitable calves being drowned in a damn, following his work the DEPI prosecuted. Barrie has also pushed Racing Victoria to acknowledge that stud farms are not registered and as such, there is no control of over breeding. He provides a wealth of knowledge when speaking with callers and advises them of their legal rights for companion animals.

We are trying to build this back up so that we can keep achieving wonderful things like the win with Central Coast Council.

## **CORAL | AL BATEMANS BAY**

The Batemans Bay branch has been running for just over one year now. We were doing markets stalls as at least once a month at Corrignas Beach Reserve Batehaven (Batemans Bay) (sometimes twice a month), street stalls, as well as weekly Batemans Bay market stalls. Due to the fires and coronavirus, we have been unable to run these stalls, but can't wait to get back into it.

We are currently running a petition highlighting the cruelty to animals in rodeos to present to our council who issues the licence for our own local rodeo, which occurs annually on New Years Eve. We recently held an outreach stall on Melbourne Cup to highlight the cruelty in the horse racing industry.

I am also considering running for council again, with the Animal Justice Party.
